

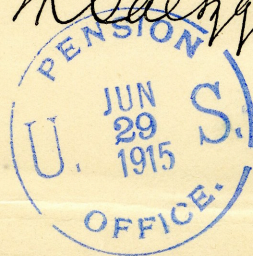



The name of organizations in which you served? Answer. *Comp. A 1st Battalion Rifle Missouri Infantry*
- No. 2. What was your post office at enlistment? Answer. *St. Louis Missouri*
- No. 3. State your wife's full name and her maiden name. Answer. *Augusta Hurwitz (M. Name Augusta Fender)*
- No. 4. When, where, and by whom were you married? Answer. *April 17, 1876 in Lima Peru by the Rabi Jacob Jacobs in the presence of Mr. Clayton the U.S. Consul*
- No. 5. Is there any official or church record of your marriage? Answer. *Recorded in the Am. Consulate Callao*

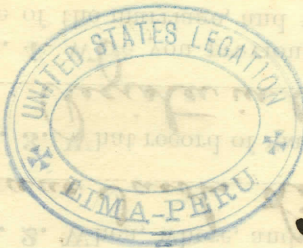
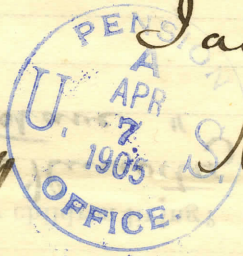
